Fund concept

HYPO-INVEST is a mixed fund that invests exclusively in securities denominated in euros. The fund's assets are spread across a broadly diversified portfolio of different countries and sectors. The maximum equity risk is 50% of the fund assets, whereby the minimum investment limit of 30% of the fund assets may not be undercut. Within the respective asset classes, both individual securities and fund products are used. Derivatives are used for tactical adjustments of the asset allocation as well as for hedging purposes. The fund is suitable for severance pay and pension provisions pursuant to § 14 EstG as well as for acquisitions within the meaning of the profit allowance (SME promotion) pursuant to § 10 EstG. The fund follows § 25 PKG.

The fund may invest 35% or more of its assets in securities or money market instruments issued or guaranteed by one of the following issuers, provided the investment is made in at least six different issues, whereby the investment in one and the same issue may not exceed 30% of the fund assets: Austria, Germany, France, Netherlands, Italy, Spain, Belgium. In accordance with the investment strategy, the management company may enter into transactions with derivatives on behalf of the investment fund.

Due to the use of investment instruments satisfying the eligibility requirements set forth in the fund regulations, the fund experiences a higher level of volatility. This means that the share value can be exposed to significant upward and downward movements even within a short timeframe.
